# WELCOME TO ROYAL & DERNGATE

Royal & Derngate (Northampton Theatres Trust) is seeking a Chair for our Board of Trustees.

With proven strategic knowledge of the arts and charity sector and a conviction that the arts are vital for the pride and wellbeing of a thriving town and county, you will join the theatres at an important time.

As you'll read in our biography and in our update of the last 12 months in this short pack, we are looking towards an exciting future. While we continue to weather the obvious challenges of this Covid era, we do not underestimate the important role we will play as the country emerges from the pandemic.

Before we were forced to close our doors in March 2020 due to Covid-19, Royal & Derngate was enjoying record audiences and attendance. With an annual local economic impact of over £28m, we were proud of our broad portfolio of producing, presenting, community engagement, work with children and young people, and sector/local leadership. More than **337,000** had been through our doors in Northampton to our programme of presented and produced shows, films or community activity that previous year and a further **265,586** seen our work across the country on one of our tours or West End transfers.

The largest Arts Council National Portfolio Organisation in Northamptonshire, we are often looked to by funders and other stakeholders to provide a lead for the local cultural sector. We are currently collaborating with partners to create a Cultural Compact, a new ten-year cultural strategy for Northampton and are represented on the Board of Northampton Forward, a new strategic driver for wider economic and town centre regeneration.

A number of strategic initiatives locally have created a 'perfect storm' of positive change in Northampton

over the last 2 years. As well as an impending move to a combined local authority, the University of Northampton has moved to a new £330m town-centre campus, an expanded museum offer will open in 2021 following a £7m redevelopment, and the £14m Vulcan Works CCI hub opposite Royal & Derngate will welcome artists and businesses shortly after. NN Contemporary are relocating to a former council building on Guildhall Road with whom we are hoping to partner on their plans for further exciting transformation.

We reflect a little on the impact of the pandemic on page 6 of this document. We are also looking closely at how we will need to change and evolve in the coming months and years to ensure we continue to play a vital part in the lives of all our communities, and continue our important national and industry-wide role as an award-winning producing theatre. Our new Chair will be integral to all of these exciting developments.

We are an inclusive organisation, committed to fair recruitment, induction, training, succession planning and equality of opportunity.



# ABOUT THE ORGANISATION

Royal & Derngate comprises a 1,200-seat multi-purpose auditorium and 450-seat Victorian playhouse that present a mixed programme of high-profile touring shows and artists all year round and host our award-winning Made In Northampton series of in-house produced theatre productions. A 100-capacity studio doubles as both a workshop space for children and young people, and an ad hoc small scale performance space (Underground Studio). In June 2013 we opened an 88-seat independent cinema, operating full time adjacent to Derngate, the Northampton Filmhouse. Such was its success, that we opened a second screen in 2017.

We are the main venue for arts and entertainment in Northamptonshire. Named Regional Theatre of the Year in The Stage Awards in 2011 (and nominated again in 2016), we won the UK Theatre Awards for Best Presentation of Touring Theatre in 2015 and Best Touring Production in 2016 for *The Herbal Bed*, and The Stage Ensemble Award and a Fringe First for *Education, Education, Education* in 2017. *The Worst Witch* won the 2020 Olivier Award for Best Family Show, whilst *Our Lady of Kibeho* was nominated for a 2020 Olivier Award for Outstanding Achievement, *The Season* earned its composers the Stage Debut award and Michael Billington awarded us

“Outstanding Regional Theatre of the Year 2020” in Country Life. Meanwhile, the adapted screenplay from our original play commission of *The Pope* was nominated for “Best Adapted Screenplay” at the Academy Awards as Netflix’s *The Two Popes*.

Alongside touring nationally and internationally our *Made in Northampton* productions have transferred to the West End and Broadway as well as Shakespeare’s Globe, the National Theatre and The Southbank Centre. Productions transferring to London last year included *The Worst Witch*, *Our Lady of Kibeho*, *Touching the Void*, *Education, Education, Education* and *The Lovely Bones*.

# ABOUT THE ORGANISATION

We present a diverse range of visiting productions on both the Derngate and Royal stages, featuring West End musicals and dance, plus comedy and music from some of the biggest artists around. We also feature a regular programme from the Royal Philharmonic Orchestra. We provide hiring opportunities for the local music service and amateur theatre companies across all our stages. Last year we hosted the UK Musical Theatre Conference, *Devoted & Disgruntled 14*, *BEAM 2020* and the *International Teach First* conference.

Our award-winning, nationally recognised *Get Involved* programme engages with over **18,576** participants

each year, including schools, families and communities in Northamptonshire and beyond, and our two-screen cinema welcomed over **76,000** audience members to the best in world, independent, British and mainstream film. Meanwhile, the *Generate* artistic development programme supports hundreds of local artists each year.

We also continue to work in partnership to manage The Core at Corby Cube which has recently celebrated its tenth birthday. A number of the Trust’s employees support the work of this sister organisation under the umbrella of Northamptonshire Arts Management Trust.

# THE LAST 12 MONTHS

Alongside many of our peers across the sector, the financial impact of the pandemic has been devastating. 90% of our income is usually drawn from ticket and bar sales. Having closed our doors on Wednesday 18 March, we embarked upon our Bring Us Back Together fundraising campaign - the response from our audiences, local partners and stakeholders was extraordinary. The team then achieved funding from both Arts Council England's Emergency Response Fund and from the Culture Recovery Fund, with additional support from Northampton Borough Council securing the future of the theatres. This enabled us to continuously deliver an extensive "At Home" digital programme of activities to our local communities, launch a drive-in cinema experience, champion hundreds of local artists through our *Generate* programme and offer employment opportunities to hundreds of freelance theatre-makers.

We were thrilled to open our cinema screens temporarily in December and look ahead to a fuller reopening of the theatre spaces in May (restrictions permitting). While there is still a challenging road ahead, the team and Board are committed to remaining a vital resource for our communities and understand the importance of the role we will play as we emerge further from the pandemic.

## KEY MOMENTS DURING COVID CLOSURE HAVE INCLUDED:

- Creating a sold-out drive-in cinema experience at Delapre Abbey welcoming **5,500** audience members over **25** screenings and launching a "Northampton Filmhouse at Home" streaming platform for new cinema releases.
- Launching a new 3-year partnership with the National Youth Theatre to provide outstanding training opportunities for up to **800** young people in 2021.
- Streaming *Made in Northampton* shows including *#ZoologicalSociety* and *Every Last Trick* to over **140,000** people online.
- Employing **150** freelance artists to develop new musical theatre during lockdown, which will culminate in four fully staged original musicals in 2021.
- Supporting over **200** practitioners by hosting the online *BEAM Festival* of new musical theatre with MMD and MTN.
- Hosting *GenFest* online festival supporting **1,700** artists.
- Launching the Northamptonshire Cultural Education Partnership consortium supporting **20,000** young people attending East Midlands schools through digital resources, challenge packs and career insights.
- Hosting the largest live-streamed online NT Connections festival in the UK.
- Handing out **480** free food parcels to children going hungry during the October half-term and manufacturing scrubs for front-line workers.
- Directly lobbying MPs, Government Ministers and stakeholders to support the wider sector, raising awareness in national newspapers and on TV, radio and social media. Leading the largest *#LightItInRed* campaign outside London in partnership with Robe UK.

# THE CHAIR

We are looking to recruit a Chair with proven strategic knowledge of the arts or charity sector to provide guidance and support to the leadership team. They will display many of the attributes and commitments listed on the next page, and supplement the skills and experiences of our existing Board of Trustees.

The Board of Trustees is the governing body of Northampton Theatres Trust (encompassing Royal & Derngate and Northampton Filmhouse). A charitable company, the Trustees have duties under charity law and company law. While operational responsibility is delegated to the theatre Executive, Trustees are responsible for the governance and the strategic direction of NTT in delivering its charitable objects. Board Meetings are normally held six times a year as well as an annual Away Day which all Trustees are expected to attend. Meetings primarily take place in Northampton though attendance via Zoom on occasion is likely to be acceptable. In addition, there are a number of sub-committees, and The Chair will be encouraged to have oversight of those committees with support from their Vice Chair. Trustees are all expected to take on additional roles as appropriate. Trustees are also encouraged to support theatre performances, fundraising events and community projects and have informal meetings with relevant members of the Executive team. All Trustees are elected for an initial term of 3 years.

# CURRENT BOARD OF DIRECTORS

## OUTGOING CHAIR: STEVE EDMONDS INDEPENDENT

Steve is a Northamptonian and Chartered Accountant. He joined the Board in January 2011 and was appointed Chair in November 2016. He is a member of the Finance Committee, which he has chaired since May 2011, and a member of the Cinema Committee. Steve has held operational and strategic board level positions with Grant Thornton in the UK and its international network. He was previously a trustee of the Royal Theatre and has been involved with a number of other local charities, including chairing the County's British Olympic Appeal and Sports Aid foundation.

## JANE BLOOMER INDEPENDENT

Jane was appointed to the Board in June 2015 and is a member of the Finance Committee. She is a practicing solicitor and director at the local law firm Howes Percival LLP, strategically managing teams in Northampton and Milton Keynes. Jane has been an amateur dancer since the age of 13, and has a particular passion for promoting the arts. She has lived in Northampton since 2005, having started her legal career in Birmingham, and still regularly participates in ballroom, Latin and modern dance events.

## JANE BUNCE INDEPENDENT

Jane joined the Board in November 2020, and is the Chair of the Nominations Committee. She studied at the University of Sheffield before qualifying as a Chartered Surveyor. Jane began working at the University of Northampton in 1995. From 2007 she was the Registrar and Clerk to the Board of Governors until in 2012 when her role changed and she became Director of Student and Academic Services. For the past six years until her retirement on July 2019, Jane was the Academic Project Manager for the University of Northampton Waterside Scheme. Jane is a member of the Surprise Northamptonshire Board and Northampton Forward Board, representing the University in both cases.

Roger joined the Board in March 2014. He is a Fellow of the Institute of Direct Marketing, and Managing Director of Star Digital an award winning Northampton based digital marketing agency. Roger has lived in Northampton since 2002 with his wife Andrea and their three children, and has a keen interest in supporting and promoting music and theatre. He is a member of the Marketing sub-committee, and Development Committee.

## VICTORIA MILES INDEPENDENT AND OUTGOING VICE CHAIR

Victoria was appointed to the Board on 20 May 2009. Victoria is the Chief Executive of the Northamptonshire Community Foundation (Northamptonshire's independent grant giving organisation). Victoria has a passion for theatre; she originally trained as an actress and singer before embarking on an earlier career with the Regional Press, and still directs and performs with various small independent performance groups such as Roundabout Theatre Company and Company MK. Victoria is a member of the Development Committee.

## HANNAH MILLER INDEPENDENT

Hannah was appointed to the Board in June 2015. She is currently the Head of Casting at the Royal Shakespeare Company. She has also cast productions for Northampton Theatres, Hampstead Theatre, the Young Vic, Cardboard Citizens, Treatment Theatre and Sheffield Theatres. Hannah also works regularly in drama schools and with other industry organisations advising actors on professional development. She has previously been a school governor in Northamptonshire, been elected to the committee of the Casting Directors Guild, and is a member of the Arts Committee.

# CURRENT BOARD OF DIRECTORS

## TANYA MOODIE INDEPENDENT

Tanya joined the Board in November 2020 and is a member of the Arts Committee. She is a Canadian born British actress & producer, and has been nominated for Best Actress at the UK Theatre Awards, the What's On Stage Awards and the London Evening Standard Theatre Awards, and twice for the Oliviers 'Outstanding Achievement' category. Tanya played Queen Constance in James Dacre's Royal & Derngate production of King John at the Church of the Holy Sepulchre, Northampton, in 2015. She is a RADA Council member, a Patron of Roundabout Dramatherapy and Act For Change, an Ambassador of Park Theatre and an Ambassador for Clean Break. She is a founding member of the Women's Equality Party. In searching for work that foregrounds untold stories of Britain's rich multicultural history, she set up a television production company (2not2) with playwright Sarah Rutherford. Two of their projects are currently in development.

## CLLR IAN MORRIS LOCAL AUTHORITY NOMINEE (NCC)

Ian was appointed to the Board in 2019. He is a shareholder in Ros Povey Productions Ltd and was a shareholder in the Old Vic Productions until a few years ago. Ian also invested in a number of shows over the years both in the West End, New York and regionally in the UK, and now owns and runs a property investment business. He is an elected Councillor on Northamptonshire County Council and is currently the portfolio holder on the Cabinet for Adult Social Care and Public Health. Ian splits his time between Northamptonshire and London and enjoys country walks, reading, the theatre and films.

## SAMUEL MUNDAY-WEBB INDEPENDENT

Sam joined the Board in November 2020 and is a member of the Arts Committee. He is a director, writer, producer and educator with experience in theatre, education and schools. In 2016 Sam founded the Great British Pantomime Awards. He has worked in community arts engagement as a director and educator in Northamptonshire and facilitates and manages the artistic programme for Brackley Youth Theatre. He also has an in-depth knowledge of Safeguarding and works with local and national organisations to support their safeguarding provision. Sam's company The Inspiration Factory offers bespoke workshops to business to promote well being and better team practices, which includes a talk about ADHD, OCD and mental health to encourage people of all ages to talk about mental health.

## KAY ROBERTS INDEPENDENT

Kay is a Northamptonian and taught in primary schools across Northampton for 38 years until her retirement in December 2016. She has been Headteacher of two primary schools for 22 years and is passionate about ensuring that there is an enrichment offer in the arts within the school curriculum for all pupils. Kay was appointed

as a Trustee in May 2017. She loves theatre and all forms of the arts, and is an active member of the Sporting Bears Charity. Kay is a member of the Representation and Inclusion Sub Committee.

## CLARE SLATER INDEPENDENT

Clare was appointed to the Board in May 2017. She is Head of New Work at the Donmar Warehouse in London. Clare also works as a freelance adaptor and dramaturg. She previously worked as Executive Director of the Gate Theatre in Notting Hill. Prior to that, Clare was the Assistant Literary Manager at the National Theatre, and worked in TV and film development with Rare Day. She is a member of the Arts Committee.

## CLLR DANIELLE STONE (LOCAL AUTHORITY NOMINEE - NBC)

Danielle was appointed to the Board in September 2015. She is the County Councillor for Abington and Phippsville and the shadow portfolio for learning, skills and education, and is Borough Councillor for Castle Ward and the leader of the Labour Group of Councillors on Northampton Borough Council. Danielle has worked in education all her life, firstly as a teacher and then as an education officer. She is passionate about arts education and wants to see all young people given opportunities to go to the theatre and to take part in productions.

## JO GORDON CHIEF EXECUTIVE

Jo has been Chief Executive of Royal & Derngate, The Core at Corby Cube and Northampton Filmhouse since 2018, having taken on this role from her previous post as Marketing & Sales Director. She has been a theatre professional for 22 years, including running her own marketing agency with clients including the Royal Shakespeare Company, Oxford Playhouse and Theatre Royal Plymouth. She also worked for Ambassador Theatre Group for 7 years and spent time overseas under contract to Creative New Zealand and St James Theatre in Wellington NZ.
